- 1 Go to myinteractivehealth.com.
- 2 New user: enter code PWAJU.
Returning user: log in with user ID and password.
- 3 Click on "Schedule Now" and select a lab location convenient for you.

No need to wait for paperwork! *Receive a code on your mobile device and present it to the lab technician, or you can download your lab requisition, print and bring it to the lab. Or call (800) 840-6100 to receive your paperwork by email, or by the U.S. mail (regular mail will take about one week).

Save Time, Paperwork and Postage!

When you register online you will be prompted to complete your health assessment. Follow the prompts until you are finished and then click SUBMIT. If you registered by phone you can go online following the instructions on the previous page. After you log in you will be able to access your health assessment from the home page.

If you choose to have your lab requisition and paperwork mailed to you, it will take about one week to arrive. If you did not complete your Health Assessment online, please complete the paper form in your packet and mail it to Interactive Health.

Things to Know

- You must use a lab that is listed in your paperwork. Addresses and phone numbers will be provided.
- Appointments are not required at most labs. We suggest that you call the lab in advance to confirm its hours of operation and whether an appointment is recommended.
- **Please fast 12 hours before your test.** Drink plenty of water – no food or other beverages. If you are diabetic, pregnant, on medication, or have a medical condition that will prevent you from fasting 12 hours, please follow your doctor's instructions regarding fasting.

Please return all paperwork and complete your lab blood draw by February 14, 2020.

This alternative course of action must be completed by March 25, 2020.
